COMPOSITE LEVY

The Composite Levy is charged for resources and services that the College provides. This may include a multitude of items, such as:

- The College technology program, which includes use of iPads / iMacs in Primary and a 1:1 device in Secondary.
- Textbooks and exercise books.
- Stationery (except Secondary). Secondary students need to provide their own stationery.
- Equipment, consumable materials, and resources for all subjects (including all electives).
- Sports and extra-curricular programs.
- All camps and excursions, including transport and venue costs (camps are not run for all year levels).
- Library resources and reference materials; and
- Maintenance and upkeep of the College's facilities / amenities.

Sibling discounts will not apply to the Composite Levy. This fee is non-refundable for both new and existing parents even if the enrolment is withdrawn.

NEW ENROLMENTS

New enrolments will incur the following fees:

- An **Application Fee** of \$100 per student; and
- An **Establishment Fee** of \$750 per student.

Both the Application Fee and Establishment Fee are non-refundable and non-transferable.

PROCESSING OF FEES FOR EARLY WITHDRAWAL:

In the event of a student, withdrawing from the College during the year, then the following will apply:

- **Student Withdrawal Form** must be completed by parents, dated signed and lodged at the College Office. Please keep a copy of this document for your own record.
- **10 full weeks' notice** should be given in writing before the withdrawal date (not including school holidays). If a full 10 weeks' notice is not given, then an additional full term's fee will be charged.

The final fee account will only be calculated once all required documentation has been provided to the College.
